Aims of JoinEU-SEE

- Facilitating the mutual enrichment of societies by supporting the development of individuals' qualifications in order to improve their employability on the labour market and help them develop openmindedness and international experience
- Promoting the academic mobility of excellent third-country students, academics and researchers, in particular from vulnerable groups, in order to offer them the opportunity to obtain qualifications and experience in the EU
- Enhancing the international cooperation capacity of Western Balkan universities by sharing good practice and knowledge in the organization of mobility programmes for the purpose of studying, joint teaching, training and research on the basis of the principles of non-discrimination and equal opportunities

Who can apply?

Students and staff members of all partner universities, both from EU and Western Balkan countries, as well as other nationals of any EU country and the Western Balkan partner countries.

Types of scholarships and duration*

The scholarship includes a monthly allowance (see below), tuition fee (where applicable), travel costs and insurance (travel, health, accident).

Level of mobility	Duration	Allowance
Undergraduate	1 semester or 1 academic year	1,000 € per month
Master	1 semester to 24 months	1,000 € per month
Doctorate	6 months to 36 months	1,500 € per month
Post-doctorate	6 or 10 months	1,800 € per month
Staff	1 month	2,500 € per month

Mobility from Western Balkan countries to EU countries

Mobility levels

Target Group I*

Students and staff registered/employed at a Western Balkan partner university. TG1 applicants need to hold the nationality of one of the Western Balkan partner countries**.

- Undergraduate
- Master
- Doctorate
- Post-doctorate
- Staff

Target Group II*

Nationals of Western Balkan countries**

- who are registered/work at a higher education institution which is not a JoinEU-SEE partner but is located in one of the 6 Western Balkan partner countries** (students and staff); OR
- who have obtained a university degree or equivalent by a higher education institution in a Western Balkan partner country** (only students).

Target Group III*

Nationals of Western Balkan countries** who are in particularly vulnerable situations. This includes, for example, individuals who

- have a refugee status or are asylum beneficiaries (international or according to the national legislation of one of the EU recipient countries); OR
- have been the object of unjustified expulsion from university based on racial, ethnic, religious, or political reasons, sexual inclination or gender; OR
- belong to an indigenous population targeted by a specific national policy or IDPs

Mobility from EU countries to Western Balkan countries

Target Group I

Students and staff who hold the nationality of one of the 27 EU member states and are registered at one of the EU partner universities.

Target Group II

Nationals of one of the 27 EU members states who

- are registered/work at a higher education institution (not included in the partnership) of any EU country (students and staff); OR
- have obtained a university degree or equivalent from a higher education institution of any EU country (only students);

- Staff

* Applicants must not have resided nor carried out their main activity (studies, work, etc.) for more than a total of 12 months over the last five years in one of the European countries
