**18. Learning methods:**

The Student is obligated to regularly attend classes (P) and theoretical/auditory exercises. During the semester, the teacher undertakes to duly monitor the presence of students. In This period the student can make the maximum three times with lectures and three times with exercises (AV). Making individual and team projects is also compulsory. During the semester each student will receive one individual or one team project. The Individual project will include one seminar work, the structure of which will be determined in consultation with the teacher and presentation before a group of students or in front of the teacher.

**19. Assessment methods:**

Assessment is conducted orally and in writing. Written assessment is conducted in the form of various tests after the lectures and classes in certain subject areas have been carried out. In case the students achieve less than the required number of points on their written test, they undertake the oral assessment. The oral part of the exam is carried out as a conversation on important topics covered in the written test on which the student failed to achieve the required number of points.

Tests

After the lectures and classes in certain subject areas have ended, the teacher will assess the acquisition of the subject matter by using tests consisting of a number of questions and tasks from the previously taught subject matter. The students will be notified of the date and time of the written assessment fifteen days in advance. Students who cheat will be removed from the exam and their tests shall not be graded. It is considered that the student passed the exam if he achieved at least 50% of the required test points.

The final part of the exam (test or oral assessment)

The second part of the exam will be organized as a written exam - a test or an independent written assignment on one of the three provided topics.

**20. Assessment components:**

The Basis for evaluating students is the following criteria:

1. Presence of lectures and exercises,
2. Activities in lectures and exercises,
3. Created and presented individual/group Project
4. Points on the written exam/test, and
5. Points achieved for the stated knowledge on the oral part of the exam,
