15. Course aims:

Introducing students to the transcription of handwritten texts in Ottoman Turkish. Analyses and classifications Ottoman diplomatic sources. working with students on transcription and introducing students to the basic characteristics of Ottoman diplomatic and paleography.

16. Learning outcomes:

At the end of the semester/course successful students will be able to understand

- general informations about ottoman diplomatic and paleography
- classification ottoman diplomatic documents
- prose texts in ottoman Turkish language
- transcription handwritten texts in Ottoman Turkish language

17. Course content:

This course contains:

- Periodization of the development of the Ottoman Turkish language
- The history of the Turkish spelling
- The elements of Arabic grammar
- The elements of the Persian language in the Ottoman Turkish
- The types of Turkish diplomatic sources
- Transcription of handwritten texts in Ottoman Turkish

18. Learning methods:

Classes are held using various multimedia teaching aids, active study and active participation of students in the teaching process. Various types of written assignments (essays, papers, seminars, etc.) as homework, in-class activities.

The language of instruction is Bosnian and Turkish.

19. Assessment methods:

Over the semester, students produce two written assignments (essays) and take the final exam on a given topic. For each of the written assignments, students can earn a maximum of 20 points. For continued active in-class participation over the semester students can earn a maximum of 10 points. Test points are calculated into the final grade if students earn at least 10 points per test.

The final exam is taken in the written form. It includes the topics covered over the semester, both in the lectures and practice classes. The maximum number of points that each student can earn is 50. In order to pass the final exam, students are required to earn at least 25 points.

20. Assessment components:

Pre-exam points amount to a maximum of 50 points and the maximum number of points that can be earned on the final exam is 50. Pre-exam points include two test over the semester, each earning a maximum of 20 points, attendance and in-class active participation for which students can earn a maximum of 10 point. This amounts to a total of 100 points (50+40+10).

The minimum number of points required to pass an exam is 54:

54-63=6 (six)

64-73=7 (seven)

74-83=8 (eight)

84-93=9 (nine)

94-100=10 (ten)

with 6 being the lowest and 10 being the highest grade.
