to adopt interdisciplinary scientific (historical, legal, political, antipolitical and other) concepts and values of civil society and their application their application everyday application and action.

**16. Learning outcomes:**

to obtain the necessary knowledge about legal theoretic, international legal comparative knowledge about democracy and human rights and their achievements in Bosnia and Herzegovina.

Students can analyze the degree of development of democracy and the rights in Bosnia and Herzegovina in relation to international standards (the European Fundamental Rights of Human Rights and Fundamental Freedoms) through a comparative analysis of individual systems,

Through seminar works, they have the opportunity to express their analytical abilities, critical observations, the ability to interpret and conclude, and in particular they will be able to demonstrate their creative abilities.

**17. Course content:**

1. Bases of democracy and human rights (historical democracy, models of democracy, constitutional democracy, liberalism, social conflicts and their solution, pluralism, tolerance, compromise, consensus)
2. Democracy and human rights (Development of human rights through history, people, human rights today, documents for protection of human rights, politics, state, rule of law)
3. Democracy (democracy and market economy, profile of ideal citizen, civil liability, civis virtute, citizen, local community, basic concept of democratic society, authority, justice, liability, privacy, education, role of media in democracy society)
4. Constitutional democracy (core values of constitutional democracy, constitution of Bosnia and Herzegovina, constitutional protection of human rights, rights of citizens protected by entity and cantonal constitutions, the European Convention on Human Rights, levels of government in B&H, division of government)
5. Bosnia and Herzegovina (unification, violence and B&H, B&H and European integration, B&H and

**18. Learning methods:**

Lectures using multimedia tools, techniques active learning and active participation with discussion of students  
Simulation of process making decisions in municipal councils  
Simulation of the between relationship organs, citizens, public services, non-governmental organizations

**19. Assessment methods:**

Analyzing concrete case studies (students will choose a concrete case from the practice that will analyze the topic closely and to say conclusion with a solemn solution to resolve the issue).  
Seminar work (the student will choose, in agreement with the lecturer, one topic that will assimilate the legal theoretical international legal comparative and experiential aspect).  
Research work (the student will choose, in agreement with the lecturer, one topic that will explore collective rights and analyze critically observe and to say conclusion from their own observations of research results).

**20. Assessment components:**

The evaluation of the exam based on the total number of points and it contains a maximum of 100 points. It is determined according to the following scale:
